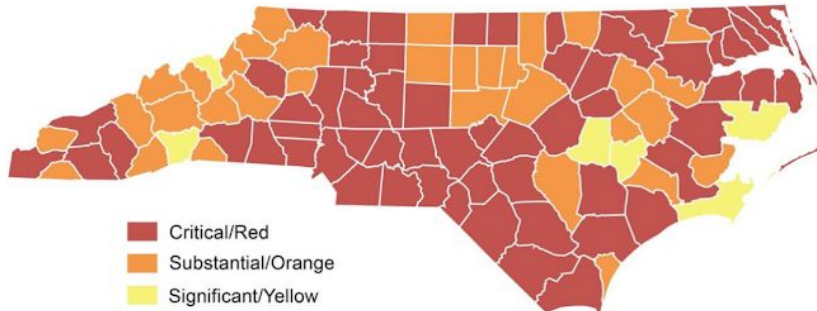

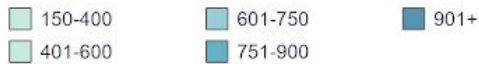
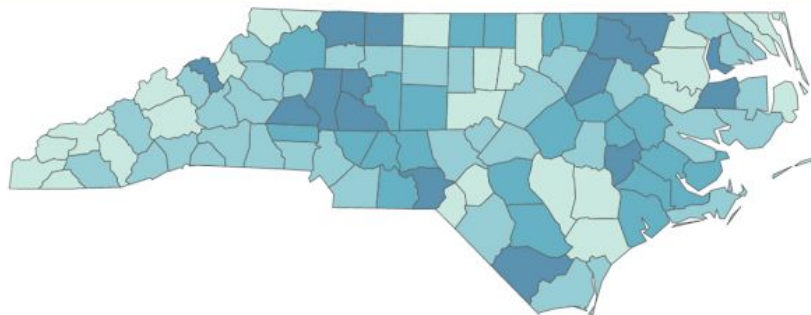
NC Counties by Tier: Data from January 17 through January 30, 2021

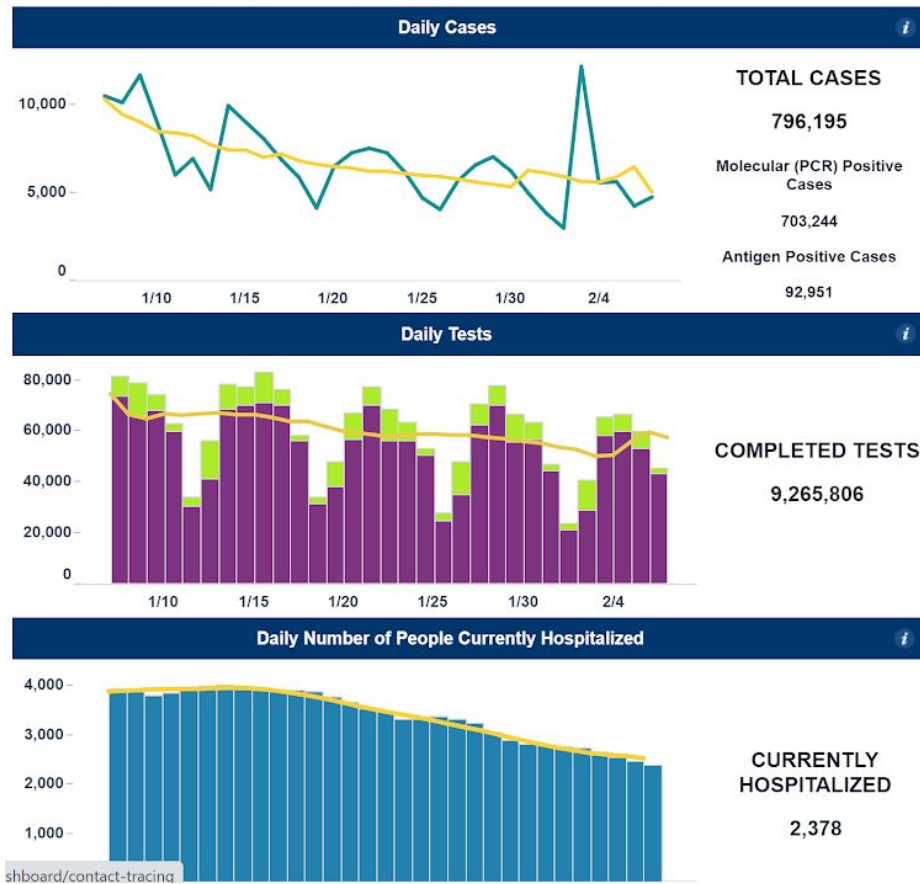

Cases at DACS since Sept -

Staff - 6 positive, 7 exposures, currently 1 positive, 1 in quarantine

Students - 15 positive, 8 exposures, currently 7 positive, 2 in quarantine

DACS Staff Survey

1. Varying levels of comfort with the vaccine
2. Comfortable working in building w/o students or with small numbers of students
3. Not comfortable with larger groups of children in the classroom
4. Suggestions: Staggered Entry, Keep up with 3 Ws in the building, Masking and Distancing
